Judge in Nirbhaya case transferred to SC registry

NEW DELHI: The sessions judge who recently issued death warrants against the four death row convicts in the 2012 Nirbhaya gang rape and murder case has been transferred. Additional Sessions Judge Satish Kumar Arora has been transferred to the Supreme Court as an Additional Registrar on deputation basis for one year, said a letter sent by Registrar General, Delhi High Court, to the District Judge, Patiala House Courts. Before his transfer, Arora was hearing the Nirbhaya rape case and other cases, including those lodged by the special cell of Delhi Police. The case is likely to be assigned to new judge soon who will be entitled to entertain any plea related to the Nirbhaya case in the trial courts. The letter dated January 20 has sought to relieve Arora immediately.

Action sought against AMU Dean for 'threatening' students

ALIGARH: The students' coordination committee of the AMU on Thursday burnt an effigy of the varsity's Dean near Baab-e-Syed gate and demanded police action against him for allegedly threatening students opposing the CAA. Former AMU Students' Union President has lodged a complaint with police. In the complaint, he alleged that while AMU Vice Chancellor Tariq Mansoor was on Wednesday persuading protesting medicos to resume attending classes, newly appointed Dean of Students' Welfare Mujahid Beg allegedly told them to be "thankful" as only hands of some of the students were broken in the police action on December 15 and "no one had been killed". The Dean's remarks infuriated the agitating students who felt that they were being threatened and pressurised to call off their stir.

MNS unveils new saffron flag, fuels speculation on ideology

MUMBAI: Maharashtra Navnirman Sena (MNS) chief Raj Thackeray on Thursday unveiled his party's new flag which is saffron in colour, setting tongues wagging in political circles about a possible ideological shift. Thackeray unveiled the new flag, which in the centre bears a 'rajmudra' (royal seal used during the times of warrior King Shivaji), at the party's plenary meeting in suburban Goregaon. The party's earlier flag had saffron, blue and green colours. Before unveiling the flag, the MNS chief paid tributes to his uncle and late Shiv Sena founder Bal Thackeray on the latter's 94th birth anniversary on Thursday.

For some political parties vote comes first, country later: Nadda

Protest over CAA

NEW DELHI

Hitting out at the parties supporting protests against the Citizenship Amendment Act, BJP President J P Nadda on Thursday said vote comes first for them and country later.

Slamming the Congress for backing the Shaheen Bagh protest, Nadda said in 2003, the then Leader of Opposition in the Rajya Sabha Manmohan Singh had urged deputy prime minister L K Advani to grant citizenship to minorities in Bangladesh. "Some people are sitting in protest against CAA but not a single Congress leader has condemned it, that is their character. If anything happens in JNU, they reach there without any delay and start crying foul," Nadda said, addressing a public meeting in Palam constituency.

In a veiled attack on Delhi's Deputy Chief Minister Manish Sisodia for supporting the Sha-

heen Bagh protest, Nadda said, "Vote comes first for them and country later. For us country is important not the vote". He added that those opposing CAA should explain what is wrong with the act. In an interaction with a news channel, Sisodia said he stood with the Shaheen Bagh protestors.

Nadda claimed that there are parties in the upcoming Delhi Assembly elections that "do not have leaders, workers and policy". "Kejriwal said he will open 500 schools, 20 colleges and buy 5,000 buses but failed to keep these promises. People should vote for BJP for development in Delhi," he said.

Rajasthan govt to introduce resolution against CAA: Pilot

JAIPUR: Rajasthan Deputy Chief Minister Sachin Pilot on Thursday said the state government will introduce a resolution against the CAA in the budget session beginning Friday. Kerala and Punjab have already passed resolutions seeking the withdrawal of the Citizenship Amendment Act. Pilot said the Centre should listen to people protesting against the Act across the country and asserted that democracy weakens if there is no dialogue. "We are requesting the central government to reconsider the Act. The Constitution has given the right to protest but if someone does it, they are attacked and called anti-nationals," Pilot, who is also the chief of the Pradesh Congress Committee, said on Thursday. "The Rajasthan Assembly will pass a resolution against the CAA in this session," he told reporters. Reacting to the proposed resolution, BIP state chief and MLA Satish Poonia said their party will oppose it in the assembly. The BJP also slammed the government for calling the assembly session on a short notice.

Nitish reacts strongly to Pavan Varma's charges,

Bihar Chief Minister Nitish Kumar on Thursday took umbrage at his senior party leader Pavan Varma for going public with reservations about the JD(U)s support to Citizenship (Amendment) Act and tie-up with BJP for Delhi assembly polls, and made it clear that the "scholdiplomat-turnedpolitician was "free to go wherever he likes".

Kumars blunt remarks came two days after Varma, a former Rajya Sabha member, sent him a two-page letter on the issue and shared screenshots of the same on his official twitter handle and facebook profile despite it containing details of conversations the two were claimed to have had "in private".

Varma, who had sought "ideological clarity" from Kumar the JD(U)s national president had arrived in the city later in the day on a private visit during which he could not meet the chief minister but demanded from him "a full statement" on CAA-NPR-NRC in view of the country-wide move-



ment against the same. "He (Varma) is a scholar-

ly person for whom I have enormous, personal respect. But the types of statements he has been giving.. it has left me flabbergasted," he said. "There should be no confusion on the stand taken by the Janata Dal (United) on issues. Our stand is always very clear. "But if he had any reservations, he could have expressed the same in a party forum. And the reference to conversations made in private! Would I ever go public with what he has said to me in private", Kumar said with obvious displeasure. "Nonetheless, I have lots of respect for him. He can go wherever he likes", Kumar said with smile on his lips, concealing the bitterness caused by the recent development.

Raj Cong worker names his son **Congress Jain to** thwart BJP

A Rajasthan Congress worker, Vinod Jain, who works as a media officer at the Udaipur party office, named his son, born in July, as Congress Jain. The municipal corporation issued a certificate to him on Tuesday which has the name of his son as Congress Jain. According to Jain, "I was quite sad when the BJP launched a campaign 'Congress mukt Bharat' and hence wanted to do something different which can be followed by the future generation."

"Therefore, I named my son Congress, so that the next generation can also do the same and the 'Congress mukt Bharat' campaign is never successful, he says.

Jain was blessed with a son after around 20 years of marriage. The two daughters of Jain were against this name and even stopped talking to him after he was adamant to name the baby as Congress.

Illegal sale of liquor rampant after permissible hours: Study

48% consumers prefer to drink out of home, 44% drinking in cars, car-parking areas and 10 % in public places

Illegal sale of liquor beyond the permissible hours in Tamil Nadu is prevalent with 44 per cent of the consumers preferring to drink in cars and vehicle- parking areas in Chennai, findings of a study that were released on Thursday said. The study was conducted by a research firm KANTAR and NFX

Digital across seven regions, including Chennai, in the country with a total sample size of 3,000. The officials of the International Spirits and Wines Association of India (ISWAI), quoting the study here, said 79 per cent of the people responded saying illegal sale of liquor after permissible hours and during dry days was prevalent.

"The study states 48 per cent of the consumers prefer to drink out of home in the city, with 44 per cent drinking in cars, car-parking areas and 10 per cent drink in public places," ISWAI executive chairman Amrit Kiran Singh said. Some of the other issues faced by the industry was the price variations of liquor across outlets and non-availability of desired brands.

Nearly four or five consumers have highlighted the unavailability of desired brands while seven out of 10 respondents have witnessed 'price variations', they said. A significant proportion of consumers has



acknowledged paying extra or using their contacts to purchase desire brands. The study also revealed that many youngsters in Chennai were drinking illegally following regulatory restrictions.

Liquor outlets are open from noon to 10 pm in Tamil Nadu. The officials of ISWAI and the National Restaurant Association of India, referring to the findings of the study, have knocked at the door of the Tamil Nadu government to curb 'irresponsible drinking'.

"With the issue of unavailability of preferred brands being a key issue in Chennai, we call for your attention to more brands being made available through the TASMAC eco system", ISWAI officials said in a press release. The officials also suggested that drinking in cars and vehicle parking areas may be curbed by more 'liberal licensing framework' including bar licences for fine dine standalone restaurants similar to those norms followed in metros.
