- Project implementation is on-time and progressing as planned.
- Amount spent on project till Sept 30, 2017 Rs. 2751.18 crore (Approx.)
- Basic engineering design and order placement for all material is complete.
- Construction work at site on civil foundations, prilling tower shaft, control room (CCR) and under-ground piping is complete. Construction work on steel structures, equipment installation, site-fabricated equipment, above-ground piping and finishing work of various buildings is in progress.

#### **New Urea Project – Progress Status**

- Construction of low-height dam on Kalisindh river / Parwan River to augment raw water storage by 6 million cubic meter (MCM).
- Electrical sub-station energized on 18-Oct-2017.
- Natural gas supply agreements were signed on June 13, 2017 with GAIL (India) Limited and Indian Oil Corporation Limited for supply of 1.9 MMSCMD and 0.3 MMSCMD of natural gas, respectively.
- Manpower recruitment for new plant is being done in phased manner. These persons are placed in existing plants for on-job training.
- Necessary preparations for pre-commissioning activities of plant is in progress.
- Gas turbine generator trial operations are planned in December, 2017.
