Power producers' outstanding dues on discoms spike by 20%

New Delhi, April 9

OUTSTANDING DUES OF power producers on electricity distribution utilities have increased by more than 20% to ₹40,804 crore in January 2019 compared to the year-ago month, adding to the woes of the stressed sector.

According to PRAITI portal, discoms owed a total of ₹3,848 crore to power generation companies in January 2018.

The portal was launched in May 2018 to bring transparency in power purchase transactions between generators and discoms.

In January this year, total overdue amount, which was not cleared even after 60 days of grace period offered by generators, stood at ₹26,052 crore against ₹20,264 crore in same month in 2018.

Power producers give 60 days time to discoms for paying bills for the supply of electricity. After that the outstanding becomes overdue and generators charge penal interest on that in most of the cases.

The data on the portal indicates that the outstanding as well as overdue amount has also increased over the preceding month. In December 2018,



total overdue of ₹26,052 crore on discoms. NTPC alone has overdue amount of ₹8,200 crore on discoms, while NHPC has ₹1,596 crore and Damodar Valley Corporation at ₹1,131 crore.

Discoms owe the highest overdue of ₹5,790 crore to Avere Power followed by Bajaj Group-owned Lalitpur Power Generation Company Ltd at ₹1,805 crore and GMR at ₹1,788 crore among private generators.

To address delayed payments by discoms, a high-level committee headed by Cabinet Secretary PK Sinha had recommended that public finance institutions (PFIs), such as REC and PFC, may discount the receivables from discoms and make an upfront payment to the generators. Against that, the PFIs will realise their dues from discoms in due course of time and charge interest for the period of delay in payment by discoms.

In the case of a default by discoms, the PFIs be covered with a tripartite agreement with the Reserve Bank of India and the states where the RBI can deduct the money directly from the accounts of a state and pay the financial institution.

NTPC has a similar mechanism with the states and the RBI against default by discoms.

'2019 election to see male-female voter turnout gap narrow to below 4%

THE GAP BETWEEN male and female voters is set to close further in the upcoming general elections mainly due to increasing women empowerment achieved through schemes like Jan Dhan and Mudra, a report by SBI Research said. However, it said that 10 states including West Bengal and Maharashtra accounted for nearly 1.2 crore missing women voters — those who were eligible to vote but not registered in the electoral rolls.

The gap in male and female voters had already declined to only about 4% in 2014 after remaining stagnant at over 8% between 1996 and 2004. States like Bihar, UP, MP, Maharashtra and J&K, which are not traditionally known for active voter turnout, show wider gap between voting percentage of two genders.

women empowerment is the number of accounts which have been opened through Jan Dhan and Mudra schemes. There is now increasing evidence that Jan Dhan accounts are acting as a vehicle for remittances apart from others that is resulting in more and more women taking independent decisions," the report said.

Nationally, over 73% of Mudra loans have been given to women applicants while 53% of Jan Dhan accounts are operated by them.
